About Schiphol Group

Schiphol Group is an airport operator headquartered in the Netherlands and aims to rank among the world's leading airport companies. We create sustainable value for our stakeholders by developing AirportCities and by positioning Amsterdam Airport Schiphol as Europe's preferred airport. Schiphol ranks among the leading, most efficient transport hubs for air, rail and road connections and offers its visitors and the businesses located at Schiphol the services they require 24 hours a day, seven days a week.

A prime example of what we mean by an AirportCity is Amsterdam Airport Schiphol. In terms of passenger numbers, Amsterdam Airport Schiphol is the fifth-largest airport in Europe, and ranks in third position for cargo. Apart from our Dutch operations (Amsterdam Airport Schiphol, Rotterdam The Hague Airport, Lelystad Airport) we are active in the United States, Australia, Italy, Indonesia, China, Aruba and Sweden and own a strategic 8% share in Aéroports de Paris since 1 December 2008. Schiphol Group is structured and run as a commercial enterprise with a socio-economic function.

In 2009, revenue totaled EUR 1,154 million with a net result of EUR 132 million. Shareholder's equity as at year-end 2009 amounted to EUR 2,975 million. Schiphol Group employs 2,395 people.

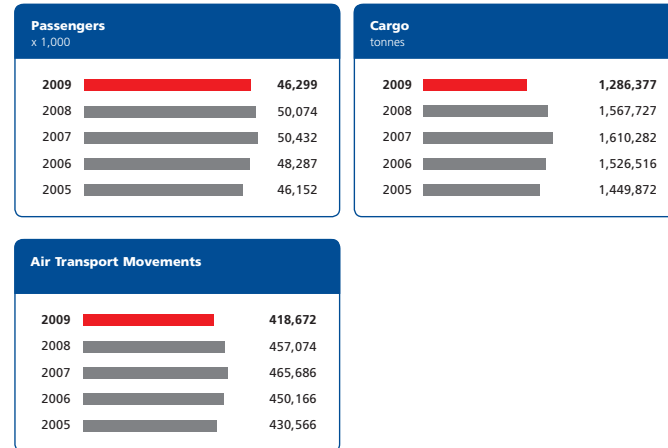

Business Areas

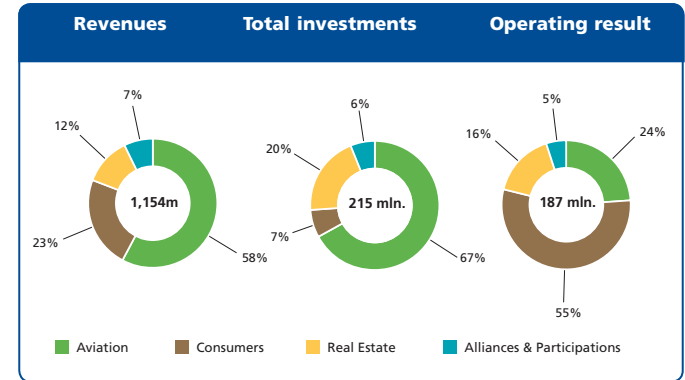
Schiphol Group's operations are organised into four business areas.

The **Aviation** business area operates at Amsterdam Airport Schiphol and provides services and facilities to airlines, passengers and handling agents.

The activities of the **Consumers** business area comprise the products and services offered to passengers and visitors, such as shops, food service outlets, entertainment and parking.

Real Estate develops, manages, operates and invests in property at and around Schiphol and other airports.

Alliances & Participations consists of Schiphol Group's interests in the regional airports in the Netherlands and its interests in airports abroad.



Aviation business area

The Aviation business area operates at Amsterdam Airport Schiphol. Aviation provides services and facilities to airlines, passengers and handling agents. The Netherlands Competition Authority (NMA) regulates the charges levied.

Sources of revenue: airport charges (aircraft, passenger and security charges) and concession fees (paid by oil companies for the right to provide aircraft refuelling services).

Consumers business area

The activities of the Consumers business area comprise granting and managing concessions for shops, food service outlets and entertainment, operating shops and car parks, and marketing advertising opportunities at Amsterdam Airport Schiphol.

The Consumers business area also has activities outside the Netherlands, including the operation of retail outlets via management contracts.

Sources of revenue: retail sales, concession fees, parking charges, advertising and management fees.

Real Estate business area

The Real Estate business area develops, manages, operates and invests in property at and around airports at home and abroad. The greater part of the portfolio, comprising both airport buildings and commercial properties, is located at and around Amsterdam Airport Schiphol.

Sources of revenue: income from the development and lease of land and buildings. The business area also contributes significantly to Schiphol Group results through other sources of property-related revenue (results from sales and fair value gains on property and the lease of land).

Alliances & Participations business area

Alliances & Participations consists of Schiphol Group's interests in the regional airports in the Netherlands, its interests in airports abroad, as well as Utilities and Schiphol Telematics.

Sources of revenue: in the case of the regional airports, these are primarily airport charges and parking fees. The various Schiphol Group associates contribute to group results through performance fees and dividends as accounted for in share in results of associates and interest income. Intellectual property fees are also reflected in the revenue. The Utility activities generate revenue from the transport of electricity and gas and from the supply of water to third parties. Schiphol Telematics generates revenue from IT and network services. With the application of the equity accounting method, changes in the fair value of the investments are not reflected in the results.

Amsterdam Airport Schiphol

During the whole of 2009 or part of it, Amsterdam Airport Schiphol provided direct connections to 284 European and intercontinental airports in 93 countries.

With passenger numbers totaling 43.6 million, Amsterdam Airport Schiphol ranked as Europe's fifth-largest passenger airport in 2009, and Europe's third-largest individual cargo airport handling over 1.28 million tonnes of cargo in that year. Air transport movements in 2009 totaled 391,264 making Amsterdam Airport Schiphol the fifth-largest European airport in terms of air transport movements in 2009. The airport is an important location for businesses. 544 companies were located at the airport in 2009, offering direct employment to 60,000 people.

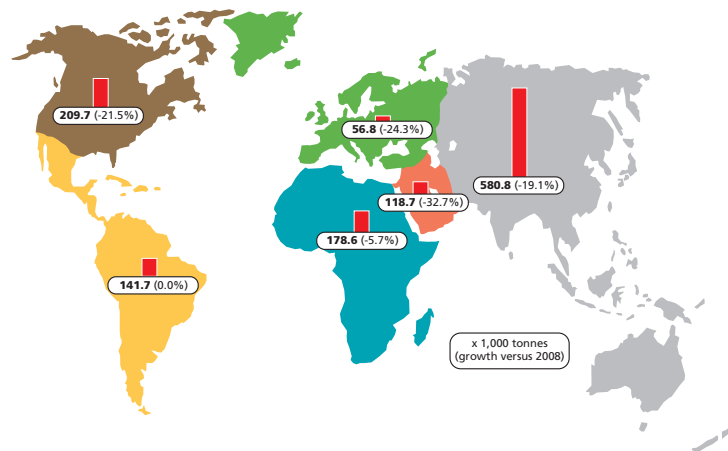

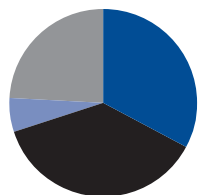

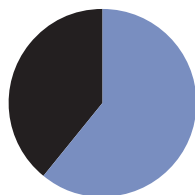

Residence



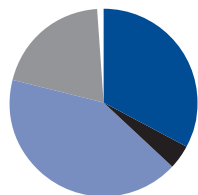

Gender



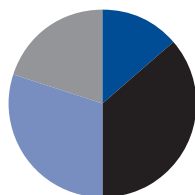

Awards

Amsterdam Airport Schiphol has been honoured with over 160 international awards since 1980 either as Best Airport in Europe or Best Airport in the World in different categories (overall, tax free, cargo, etc).

The airport won the following awards in 2008:

- 'Best European Airport 2009', awarded by readers of British business magazine Business Traveller to our airport for the 26th time since 1980.
- 'ACI Europe Best Airport Award', awarded by the trade association for European airports, ACI, for the high standards of quality maintained by our airport, with a specific reference to the covenant of the Alders Round Table and the manner in which Amsterdam Airport Schiphol handles its relationships with local residents.

- 'Favourite International Airport 2009', an award presented by Canadian travel agents to Amsterdam Airport Schiphol. Schiphol received this award on account of its one-terminal concept, efficiency, and diversity of facilities.
- 'Best European Airport', awarded by readers of Asian cargo magazine Cargonews Asia to Amsterdam Airport Schiphol for the 16th time, and 'Best Air Cargo Terminal Europe', awarded by readers of the same magazine for the 11th time due to the high quality of our cargo facilities and the efficiency of our cargo transfer process.
- 'Leading Edge Award 2009', awarded by readers of the US business travel magazine Executive Travel Magazine (published by the business travel arm of American Express), on account of our leadership, customer focus and vision.

Airport Network

Schiphol Group owns and operates Amsterdam Airport Schiphol and the regional Dutch airports of Rotterdam and Lelystad and has a 51% stake in Eindhoven Airport. Schiphol Group also has international operations at Terminal 4, JFK Airport, New York USA, and at Brisbane Airport, Australia.

Schiphol Group has a strategic cooperation with Aruba Airport.

In 2008 Schiphol Group and Aéroports de Paris have entered in an alliance, HubLink, and both airport companies have taken a 8% share in each other.

Schiphol Group USA, a Schiphol Group subsidiary, has a 40% shareholding in the JFK IAT consortium, which revamped and operates Terminal 4 at JFK Airport. JFKIAT 's contract of management and operations of Terminal 4 is valid until 2025. Terminal 4 is the only terminal at JFK Airport which is open 24-hours-a-day.

Schiphol Australia, another Schiphol Group subsidiary, has a 18.7% share in Brisbane Airport Corporation Holding (BAC), the company operating Brisbane Airport from 1 July 1997 for a fifty-year period.

Other International activities

In addition to managing airports (other than Amsterdam Airport Schiphol) Schiphol Group also operates elements of the AirportCity formula at other airports. Examples are Schiphol Real Estate's property operations near Eindhoven Airport and Milan Malpensa Airport (Italy).

Schiphol Group also has an 18.75% interest in Tradeport, a logistics complex at Hong Kong Airport. In 2004 Schiphol Group established a joint venture with the operator of Stockholm-Arlanda Airport to manage the retail facilities in the airport's terminal. The contract was expanded in January 2010 to include the retail facilities at Göteborg.

In 2008, Schiphol Group and Guangzhou Baiyun International Airport signed a two year contract for the development of commercial activities at the airport in Guangzhou.

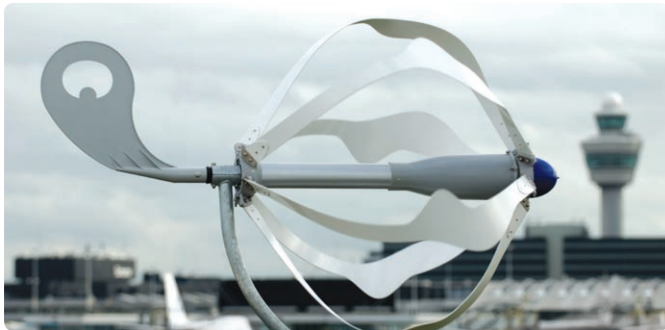
Corporate Responsibility

Corporate Responsibility – doing business with all due respect for man and the environment – is an intrinsic element of our strategy.

The Amsterdam Airport Schiphol strategy distinguishes between four separate issues with respect to Corporate Responsibility: safety, sustainability and the environment, people and society, innovation.

Amsterdam Airport Schiphol intends to be completely CO₂ neutral by 2012 with respect to its own activities and to generate at least 20% of our energy requirement at the Schiphol site by sustainable means by 2020.

Schiphol Group also has taken steps with regards to air quality and mobility, noise, water, waste and being a responsible employer.

- Amsterdam Airport Schiphol is the world's oldest international airport that is still located on the same field where the first plane landed in 1916.
- Amsterdam Airport Schiphol is the second lowest international airport in the world. It is 4.5 meters below sea level. Only Rotterdam airport, part of Schiphol Group, is lower: 6 meters below sea level.
- Amsterdam Airport Schiphol was the first airport on European mainland to have tax free shops.
- Amsterdam Airport Schiphol was the second European airport with an environmental system based on ISO 14001.
- In 2001, Amsterdam Airport Schiphol was the first airport in the world where passengers passed Passport Control with the help of iris recognition.
- In 2002, Amsterdam Airport Schiphol was the first airport in the world to host a museum with paintings by old masters: The Rijksmuseum Amsterdam Schiphol.
- The Schiphol Terminal has a floor area of 600,000 square metres.
- Schiphol is the first airport in the world to use a robot to load baggage containers.
- Since 1980, Amsterdam Airport Schiphol has won more than 160 awards as best airport of Europe or the world.
