Dear airline customer,

With this letter, Schiphol would like to inform you about the adjustment of the airport charges and conditions of Amsterdam Airport Schiphol that will apply as of April 1, 2021.

Schiphol published its formal proposal, based on the settlement 2019, for the adjustment of the charges 2021 in September 2020.

When setting the charges and conditions, Schiphol has taken into account the views of the airlines that were brought forward during the consultation period.

Although Schiphol has decided to set the airport charges for 2021 unchanged compared to the proposal in September 2020, based on received views, Schiphol has decided not to invoice the 5% increase in charges as of April 1, 2021 for a period of 6 months. Schiphol has also made adjustments to some of the conditions for the allocation of gate and stands (RASAS).

Compared to final setting in October 2019, as a result of the settlement 2019, the formal charges 2021 will be adjusted as follows:

- Landing & Take-Off charges: +€0,05*
- Passenger Service Charge OD: +€0,18
- Passenger Service Charge TRF: +€0,07
- Security Service Charge OD: -€ 0,01
- Security Service Charge TRF: -€0,01
- Parking Charge: +€0,02

* For connected handling during the day, noise category S3
